



# International Training and Methodology Centre for Financial Monitoring



The International Training and Methodology Centre for Financial Monitoring (ITMCFM) was established in December 2005 by the Russian Federation Government decree. ITMCFM's founder is the Russian financial intelligence unit - Federal Financial Monitoring Service.

The Center acts as an important structural component of the Russian anti-money laundering system, it helps Russia's partners around the world to strengthen their national AML/CFT systems through human resource development.

## Training and methodological support

ITMCFM coordinates activities of the network AML/CFT Institute participants, takes part in development of educational programmes, professional specializations and AML/CFT teaching materials, organizes scientific conferences, and promotes exchange of scientific and educational resources among the Institute participants.

## International events

ITMCFM holds international events in collaboration with the UN, OSCE, FATF, FATF-style regional bodies, World Bank, and other organizations.

## Personnel training for national AML/CFT systems

Every year, ITMCFM organizes more than 100 training courses, workshops and other activities for officers of financial intelligence units, law enforcement, supervisory, regulatory and other authorities, as well as representatives of the private sector of Russia and its partner states.
